## Sub: Postal Ballot - Scrutinizer's Report

- 1. By the resolution passed by the Board of Directors of Vascon Engineers Limited ('the Company') at its meeting held on, May 17, 2016, I was appointed as "Scrutinizer" for the purpose of:
  - a. Scrutinising the postal ballot [e-voting process (remote e-voting) and examining prepaid postage envelopes containing physical ballot papers] under the provisions of section 110 of the Companies Act, 2013 ('the Act') read with Rule 22 of the Companies (Management and Administration) Rules, 2014 ('the Rules').
- 2. The management of the Company is responsible to ensure the compliance with the requirements of the Act and the Rules relating to the postal ballot process [i.e. by remote e-voting and voting by prepaid postage envelopes] for the resolution contained in the



Postal Ballot Notice dated August 11, 2016. My responsibility as a scrutinizer for the voting process of voting through electronic means (i.e. by remote e-voting) and physical ballot papers received through prepaid postage envelopes is restricted to make a consolidated scrutinizer's report of the votes cast "in favour" or "against" the resolution stated in the notice, based on the reports generated from the e-voting system provided by Karvy Computershare Private Limited ('Karvy'), the Agency authorized under the Rules and engaged by the Company to provide e-voting facilities for voting through electronic means, and based on the examination of the physical ballot papers received through prepaid postage envelopes.

- 3. The Company had completed the dispatch of postal ballot forms/emailed details of electronic voting to the members on August 12, 2016, whose names appeared in the Register of Members/Records of the Depositories as on August 5, 2016.
- 4. The Company had entered into arrangement with Karvy Computershare Pvt Ltd for providing electronic voting facilities to all the members who were eligible to take part in the voting process.
- 5. No physical ballot papers were received by me in prepaid postage envelopes with respect to the postal ballot notice sent by the Company on August 11, 2016.
- 6. The particulars of all electronic votes casted by the members have been entered in a separate register maintained for the purpose.
- 7. All electronic votes received up to the closing of working hours on Wednesday September 14, 2016 were considered by me for the scrutiny.
- 8. I submit herewith my consolidated scrutinizer's report on the results of voting through electronic means (i.e. by remote e-voting) and through physical ballot papers (none received) on the resolution contained in the notice as under:-
